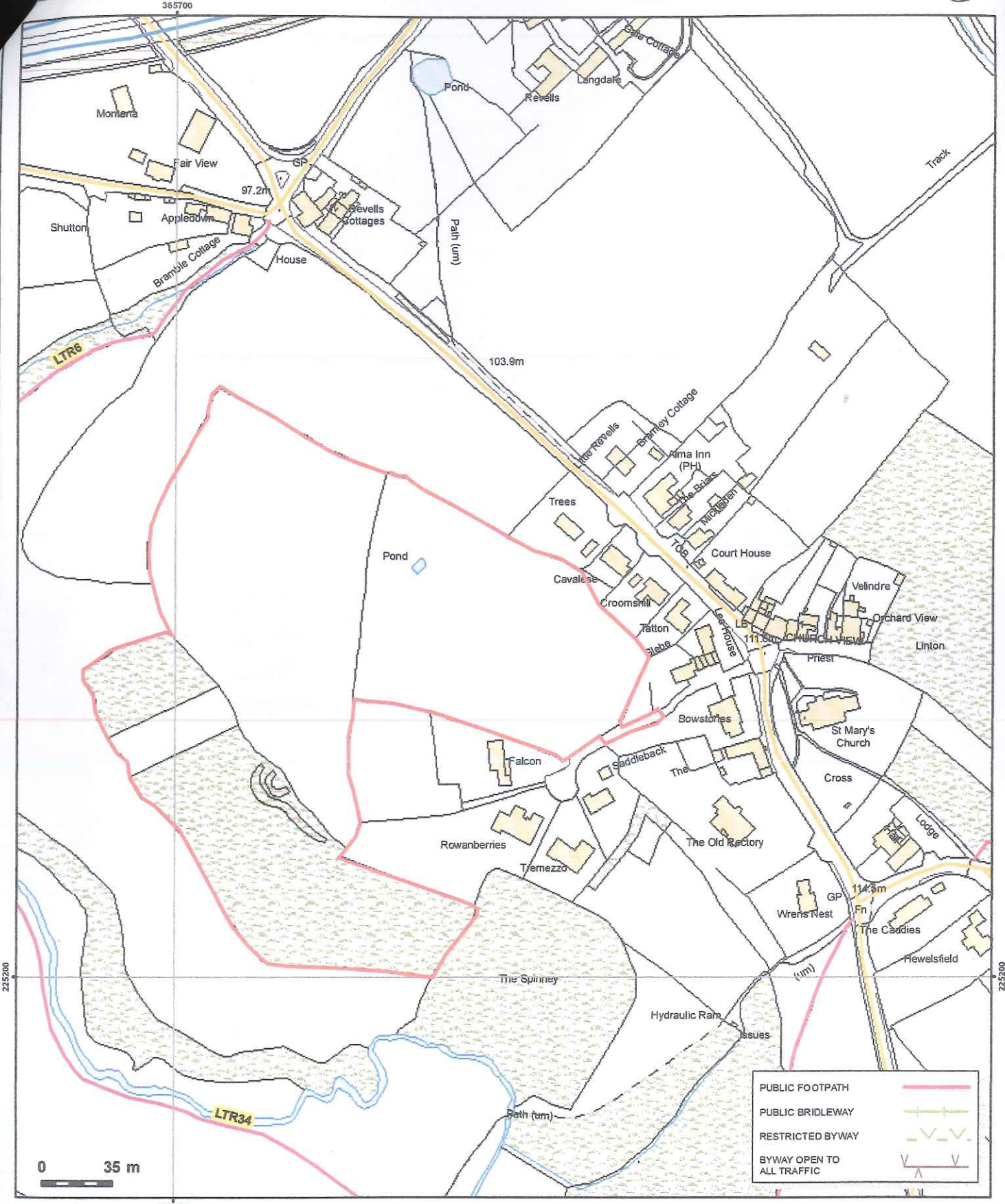

STATUTORY DECLARATION SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I Stephen John Challenger the Property Secretary of the Hereford Diocesan Board of Finance DO SOLEMNLY AND SINCERELY DECLARE as follows:

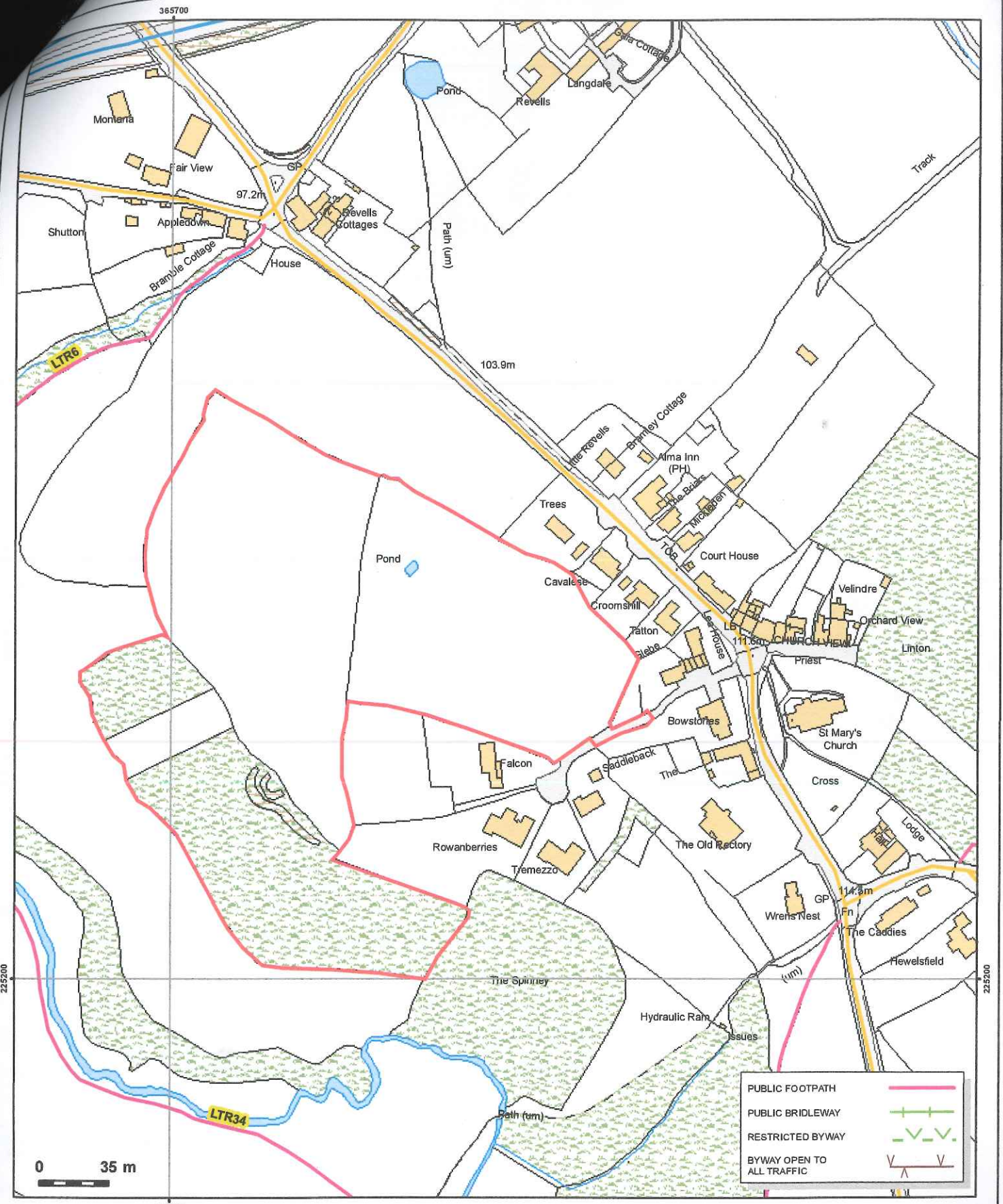
- 1. The Hereford Diocesan Board of Finance has been since the First day of April 1978 the owner of the land known as Linton Glebe more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the (day) 30th day of (month, year) January 2013 the Hereford Diocesan Board of Finance (or my predecessor in title (name)) deposited with the County of Herefordshire District Council, being the appropriate Council, a statement accompanied by a plan delineating the property by red edging which stated that [the ways coloured brown on the said plan and on the plan accompanying this declaration had been dedicated as highways with vehicular status]; [the ways coloured green on the said plan and on the plan accompanying this declaration had been dedicated as bridleways]; [the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths]; [no [other] ways had been dedicated as highways over the property] or for any other rights whatsoever for all or any section of the public over all or any parts of the property.
