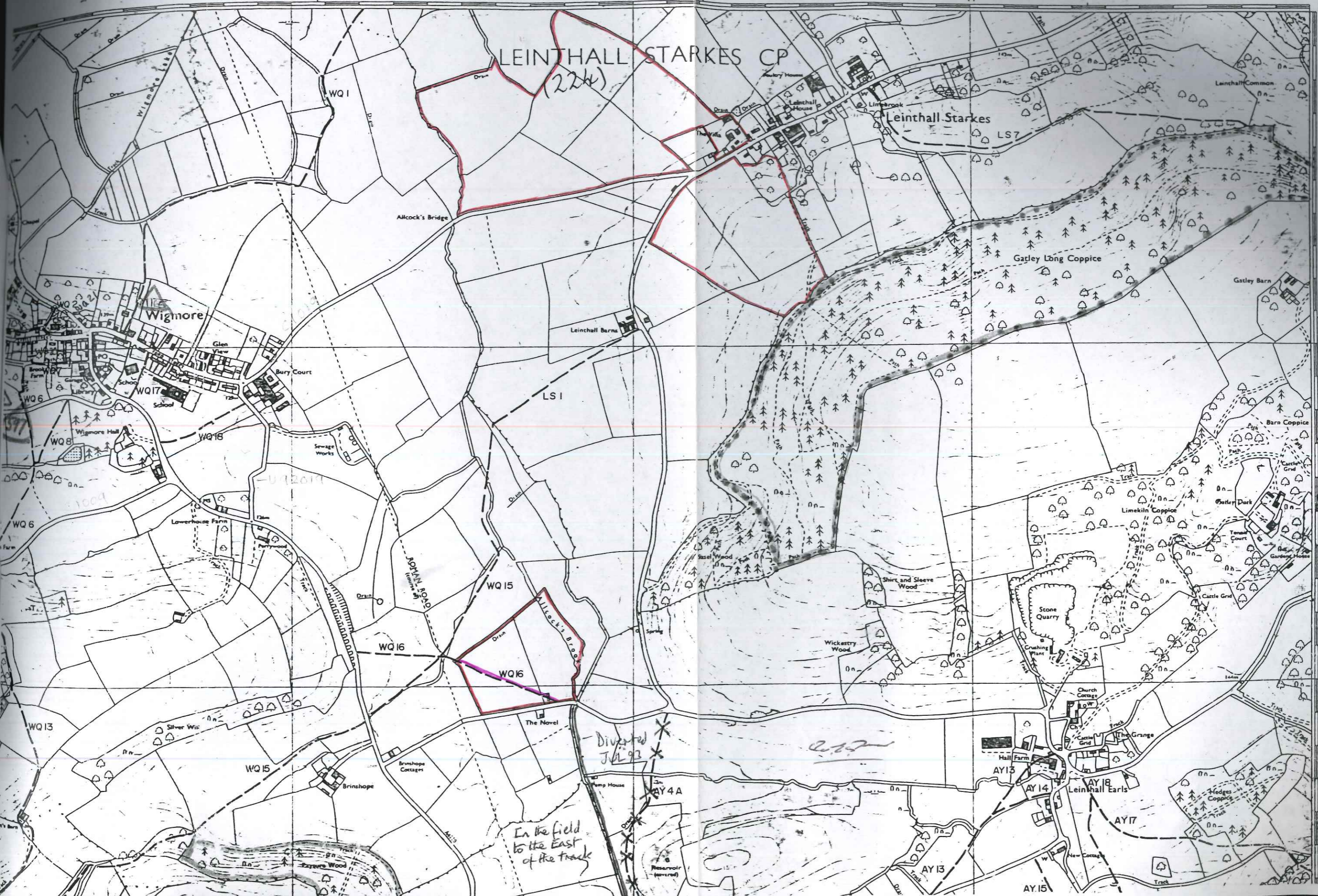

STATUTORY DECLARATION
