I AVERIL HAROLD DO SOLEMNLY AND SINCERELY DECLARE as follows:



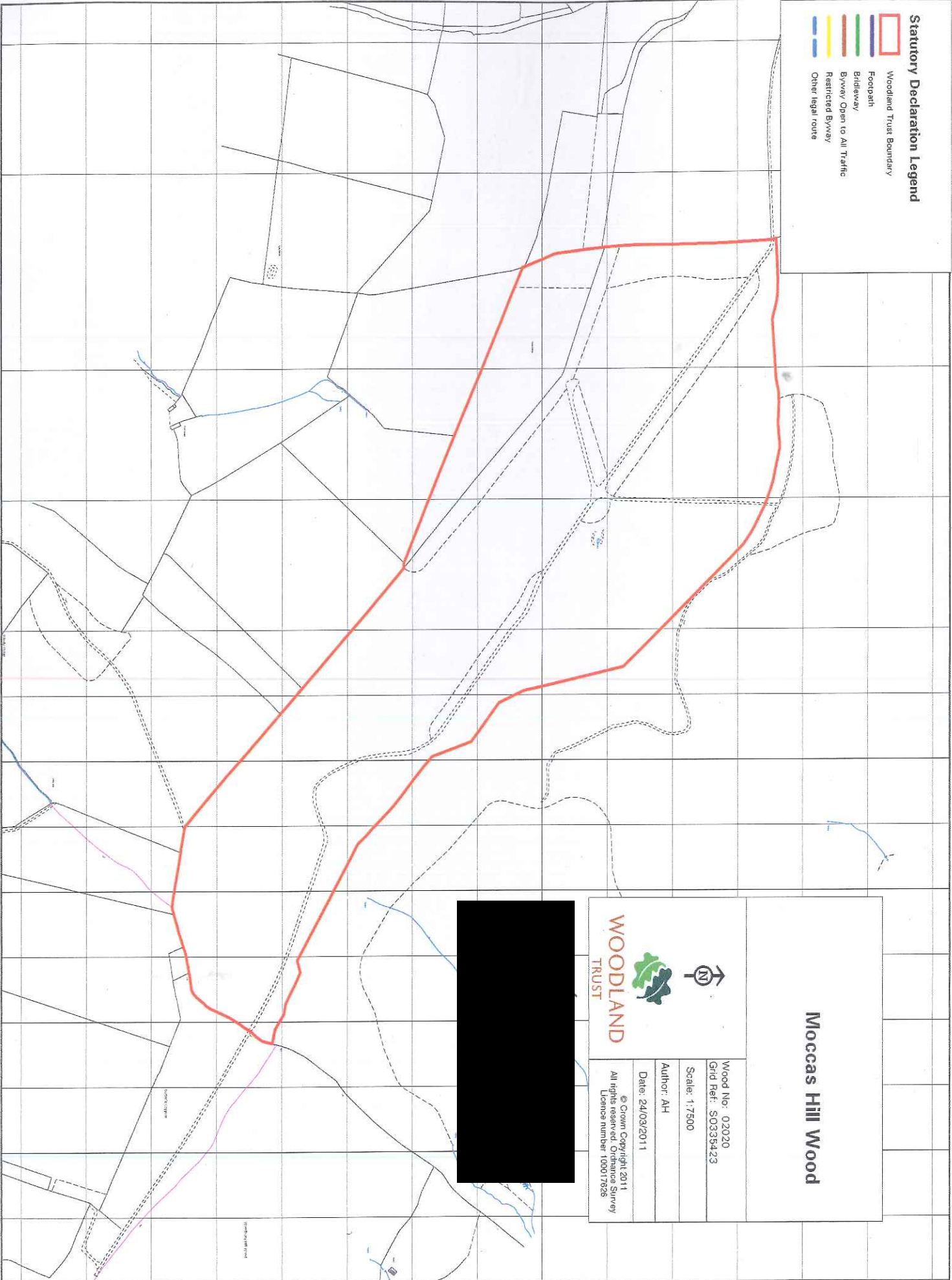
